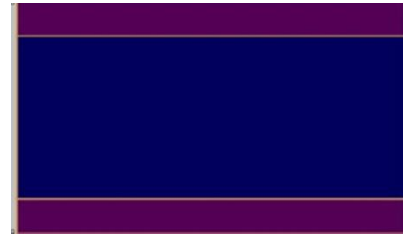

(To include all private companies operating within the States of The United States of America not limited to sheriffs, sheriff deputies, police, attorneys, judges, clerks, mayors constables, etc..)
