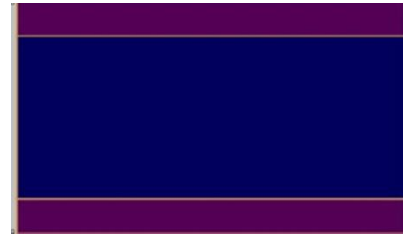

Discussion on last weeks motion to be sent to the assembly of the American Continent and to be presented to all State National Governments and the Government of The United States of America for that it may establish reciprocity.

Discussion on the ANU members recognizing members talents so they can identify their respective Unions and to structure their Union within a Sub Union as in the ANU constitution styled “ American National (respective Union) Union of The United States of America.” An example: American National Lawyers Union of The United States of America.

- All Sub Unions will adopt the ANU constitution.
- All Sub Unions will have their own Great Council with a Chairman, Deputy Chairman, Secretary, Treasurer.
- All Sub Unions shall adopt the ANU seal and place their respective Union in the middle of the seal.
- Every Great Council for the Sub Unions will delegate their problems between Sub Unions and other troubles to the Great Council of the American National Union of The United States of America.
- The Great Councils for the Sub Unions can go to the Great Council of the American National Union of The United States of America for assistance to delegate between other Sub Unions.
- Each Great Council for the Sub Unions will have their own letterheads with their own public emails.
