This meeting is called to order for the American National Trucking Union under the American National Union of The United States of America which is the restored Union of 1774. - **Interim Deputy Chairman – James O'Neill - follow-up of official business – Mr. Secretary, is there an official verification that the ANTU Constitution, By-Laws, and Rules of order have been or will be published in American Herald, as well as our last approved minutes by yourself and Chairman Beller?**

- **Interim Secretary – John Adams – Yes, the Constitution, By-Laws, and Rules of order are published and can be accessed at The American Herald News site. Our approved meeting minutes from 03022019 are published, and our approved meeting minutes from 03092019 also submitted for publishing. Added as well for the record is the following statement of goals and growth in our sub-union. Until enough people join our sub-union after established rules are reviewed and formed, there are no committee reports at this time.**

 - **Progress of the following project**
 - 1. **Discussion of contacting active leaders of the Trucking Industry in our three respective States. . The purpose is to introduce our Union and invite opinions in the formulation of the ANTU Bi-Laws to improve: safer Trucking operations, improve practicality, and increase efficiency leading to higher profits. The proposed way of contacting is a formally composed letter bearing ANTU Seal and letterhead. By focusing on Industry leaders within our three States, we can double our efforts toward re-establishing our State National**

Governments. This effort is underway and being worked on to present to the ANU before sending out.

2. Another idea to share is an International Claim stating the American National Transportation Administration has the right to authorize Commercial Operations on the roads and highways of The United States of America. Allowing this claim ninety days to cure without a challenge will create a stronger basis for another proposed idea of "setting a precedent." During the ninety day period, Bi-Laws can be formulated. A target date could be set. This idea needs further discussion with the correct parties.

- **Interim Chairman – Sean Beller**
 - **Update on Safety amendments being worked on Sean showed us a great overview of all the safety requirements by section and title that need to be amended into the ANTU Constitution and By-Laws. Sean worked very hard on these to adopt to the ANTU. The goal is to present to the ANU for review and then implement after all the right parties have seen and had input.**
- **Some discussion was held about Road and Fuel tax for the upkeep of roads and bridges.**

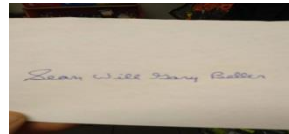
- **Interim Treasurer – Mark Fain – Update on account set up with the Continental Bank yet or any other update**
