The international banking cartel is in violation of the Law of Nations and trafficking in persons by funding the Southern Border invasion.

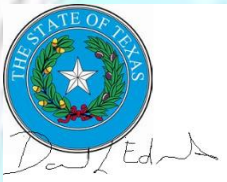

The I.C.E. agents, U.S. Military, Militias, and any other force are free from any judiciary restrictions attempting to impose foreign law against those agents.

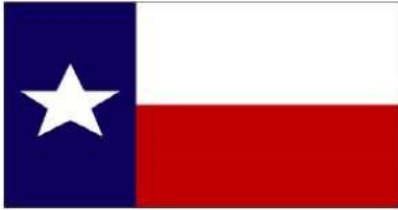
ORDER TO SHUT DOWN THE SOUTHERN BORDER
