Affidavit of International Complaint

Comes now, David Edwards, (Hereinafter “complainant”) on behalf of the North American National Party Chapter 44, to file formal International complaint against The Republican Party (hereinafter “GOP”) within Atascosa County Texas, and Eastland County Texas, who under oath complains that on Monday, April 29th, 2019, GOP and Democratic party (hereinafter” DNC”) members from the Eastland County Texas Sheriffs office violated international borders by trespassing upon private property, belonging to a private international trust, which has been claimed and imported into The United States of America, for the purpose of kidnapping the trustee of GRAHAM BRADFORD LASCSAK, PMA, (hereinafter “the trustee”) belonging to a private international trust and a member of the North American National Party Chapter 44.

Complainant advises the aforesaid party members entered onto private property and forcibly entered the private home on that private property to effect the arrest of the trustee, and not in compact with the corporate state of Texas, causing damage to the front door of the home, all reportedly in compliance with a claim of an arrest warrant stated to be issued by the Courts in Atascosa County Texas on claims of

interfering with a child custody case in regard to trustees son, and on a reported arrest warrant from Erath County Texas Courts for a violation of a child support order, even though no warrant was physically produced.

The aforementioned party members stated they had verbal confirmation of the existence of an arrest warrant issued by the courts in Atascosa County Texas and verbal confirmation was given to them by representatives of the Atascosa County Texas Sheriff's office.

The aforesaid warrant for interference of a custody order was reportedly issued by the aforementioned Court based upon a complaint from the minor Childs mother another GOP or DNC member (exact political affiliation unknown) without thorough investigation from the said Sheriff's office, after the child contacted the trustee via text to inform the trustee that the child did not want to stay at his mothers residence any longer and was leaving the mothers home.

The texts, initiated by the child beginning on the evening of Thursday April 25th 2019 and continuing into the early morning hours of Friday April 26th 2019 when the trustee arrived to pick the child up on the street, upholding the rights of the child, reveal that contact was made by the child and the request made by the child for the trustee to go to Atascosa County Texas to recover the child who claimed he had intentions of leaving the home permanently.

Complainant further states that no international due process was afforded to the trustee as thorough investigation of the matter was not conducted prior to the Atascosa County Sheriff's office appeal to the Atascosa County Court for the issuance of the claimed arrest warrant and that the trustee was kidnapped across international boundaries, by party members of the Eastland County Sheriff's office, even after they had been informed of the existence of the international boundaries, established by compact and that the claimed warrant was issued without investigation of the facts.


Physical violence in order to affect the kidnapping was initiated by party members of the Eastland County Sheriff's office by attempting to kick open the front door to the home and by using force in an attempt to forcibly overpower and subdue the trustee while the assisting party member drew and pointed a weapon at the trustee. The physical violence asserted by party members resulted in the trustee being charged in the courts in Eastland County Texas on claims of resisting arrest and assault on a foreign public officer.

The court and private company Administrator for the determination of warrant issued failed where improper jurisdiction was issued through the issuance of a wrongful warrant across the metes and bounds of a foreign Government in violation of the Law of Nations.

Complainant asserts that the aforesaid actions constitute violations of International Due Process, Kidnapping across International Boundaries, Assault, Damage to Private Property of the trustee, a member of the North American National Party Chapter 44, and the Sad L Stations Trust, a private international trust.

Further, the GOP and DNC members are requiring the Government of The United States of America to address the U.S. Secretary of State without following standard international protocol itself thereby operating as a private company(s) and not National Parties.
