- **Interim Secretary - John Adams – A Quorum is formed. Welcome to an official meeting of The Great Council of the ANTU, a sub-union of the American National Union of The United States of America. During announced discussion time on each point of order and after the meeting has ended and recording is turned off, we will take questions, so write them down or put in chat if you desire. 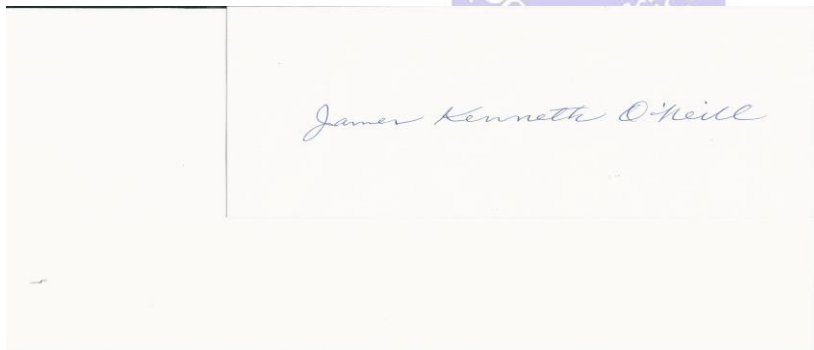
