BE IT RESOLVED, that the National assembly carried a motion to open the bank account for New Mexico and motion passed at 11:26 pm utc-7


BE IT RESOLVED, that the National assembly carried a motion to take our cases to the military tribunal and motion passed at 11:28 pm utc-7.


