BE IT RESOLVED, that a motion was carried by the national assembly to recognize and adopt the Law of the Nations; and the Universal Declaration of Human Rights, and

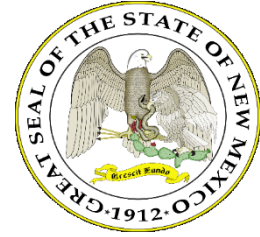


