- **Interim Secretary – John Adams – Now if there are any questions you can raise your hand electronically on the middle right of the screen. It is under who is in the**

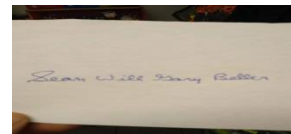
room and will note raise hand, lower hand, etc. Please lower your hand after you are finished. We will now take as many questions as possible.
