- **Interim Secretary – John Mark Adams – Quorum Status**
 - **Approved**
- **Interim Deputy Chairman – James O’Neill – Please start the recording.**
- **Interim Deputy Chairman – James O’Neill – A Quorum is formed. Welcome to an official meeting of The Great Council of the ANTU, a sub-union of the American National Union of The United States of America. During announced discussion time on each point of order and after the meeting has ended and recording is turned off, we will take questions, so write them down or put in chat if you desire. You can raise your hand in the chat room and you will be recognized. When finished lower your hand. The hand is at the bottom of those present in the room if you are new.**
- **Interim Deputy Chairman – James O’Neill – Now for Roll Call: Please state your first and last name clearly. If you think you were not heard, repeat your name for the recording. Also give the State you are from.**

- **Interim Officer Holder reports:**

Interim Secretary – John Mark Adams, Trustee:

- **States that he has four documents to show that he has worked on and two weeks of meeting minutes to show and be approved.**
- **Secretary shared the document called Updated Motions, Amendments, Resolutions, so they can be seen on line and published.**
 - **Secretary shared that on share screen.**

- **Another document shown was ‘Project Follow-up’**
- **The third document was a document for David Brian Smith, liaison from ANU to National Assembly and PMC, for updates weekly from ANTU.**
- **The fourth document was a detailed voting and delegate information doc for Neil Cornett as an ANTU liaison.**
- **The next item was the sharing of the minutes from 4/20/2019.**
 - **Sean Beller updated all on latest on Safety docs.**
 - **It is before the National Assembly and ANU for review now.**
- **The motion to approve the 4/20/2019 was made, and no discussion was given. A second was made for approval and publishing with approval for signatures from Sean Beller and James O’Neill. Motion passed and carried.**
- **The next meeting minutes were from 4/27/2019.**
- **John Mark Adams showed all where a process was already in place on filing Human Rights violations.**
 - **Noted again that firearms have to be taken care of on their own per James O’Neill and Johnny Rowe.**
- **That was the end of the review.**
- **A motion was made to pass the minutes. There was no discussion or objection. The motion had a second and was passed and carried with permission to affix Sean Beller and James O’Neill signatures.**

- **John Mark Adams then screen shared and showed all at the meeting how to go to the NANP site to join the ANTU there.**
- **The next document reviewed was for Motions, Amendments, Resolutions, Actions that have been passed or waiting to be passed since the inception of the A.N.T.U in Feb. 2019.**
 - **Note: It has been found out the original name of the Trucking Union International has to stay the way it is written in the Great Registry for Historical records. That cannot be changed.**
- **These type documents will be put on the new ANTU site on the overall web site of the ANU.**
- **There were a few words on a Bill of Lading motion for Servitude was changed for accuracy.**
- **A part about recording a Human Rights violations was brought up. The steps to process the violation was found after the previous meeting and **an Administrative Insert was included.****
- **Discussion was held on this process specifically.**
- **This process will be posted on the A.N.T.U website to follow.**
- **The Motions, Amendments, Resolutions will need to be approved by the ANU before being published.**
- **It was noted that the issue of the firearms is each person is own their own.**
- **Discussion was held on getting in front of the National Assembly leadership and how to do it.**

- **Another Discussion was held on the ‘Bill of Rights’ at the end of the ANTU Constitution, By-Laws, and Rules of Order. Questions will be asked to the leadership of the National Assembly and ANU on how all of this combines together with the ‘Hold Harmless’ and or ‘Bill of Rights’ within the ANTU By-Laws.**
- **The next document was the Project Follow-up list and be published on the ANTU web site. There are some things on the list that need to be addressed as soon as possible. Drug testing was discussed as well as CDL Licenses.**
- **The next part of the presentation was going over more details of what The Project List has on it.**

Interim Treasurer – Mark Fain:

- **The software is almost finished, as are the CBD oils.**
- **The software is about to be purchased by investors.**
- **The software is very robust and tracks all actions.**
- **There will be a presentation of it to all that can review before go live.**
- **All parts of the Continental Dollar and other trading of mediums of exchange are being considered.**
- **Discussion was held about other companies helping in this to get a PMA or whatever is needed set up now!**
- **Sean recommended that Mark gets a Continental Bank account open now.**

- **As soon as software is complete then a meeting will come together with Genoa Holdings, PMA.**
- **Sean Beller brought forth motion to the floor for ANTU Cont. Bank Account be open.**
