 - **Interim Chairman – Sean Beller:**
 - ****Motions to the floor to amend the authority and power of the office of ANU Transportation Administration to commence to begin the Commercial Operation within ANTU, to be called Division of Transportation**
 - **Create the office and fill it as more people are available to do it.**
 - **Handle Motor Carrier ID #'s**
 - **ANTU Division of Transportation numbers**

- **John Mark Adams to ask the ANU to allow the ANTU to do the vetting for all Commercial Operator Licenses.**
- **When ANTU is finished, then ANTU will send the approval to ANU Transportation Administration to finish process.**
 - **Administrative insert: After looking at Johnny Rowe's order form, there is no place for commercial vehicle plates, etc.**
- **This will be assisting the ANU Transportation Administration**
- **Checks and Balances would be in place for those working in this office.**
- **The vetting process would be:**
 - **To know the ANTU Constitution, By-Laws, Rules of Order and each one to agree**
 - **Physical abilities and limitations**
 - **Drug and Alcohol issues**
 - **Mandatory Motor Carrier #**
 - **Mandatory Division of Transportation # to owner**
 - **Thus, the motion is on the floor for the office of Transportation Division in the ANTU to do the vetting, approval, suspension, issuance, and revocation of Commercial Operator Licenses.**
 - **The ANTU would be a division of the ANU Transportation Administration**

 - **Motor Carrier #: will be ANTU O.C.T. number – which is the authority**
 - **For the door – C.C. number – Commercial Carrier # will be the last eight of VIN number.**
 - **Seconded, motion passes and carries**
