General Principles of the Duties of a Nation towards itself

“The preservation of a nation consists in the duration of the political association by which it is formed. If a period is put to this association, the nation or state no longer subsists, though the individuals that composed it, still exist.

Iger was born to a Jewish family in New York City, Iger was raised in the Long Island town of Oceanside, New York, Iger is the son of Mimi (nee Tunick) and Arthur L. Iger (b. 1926). His father was a World War II veteran who served as the Executive Vice President and General Manager of the Greenvale Marketing Corporation and was also a Professor of Advertising and Public Relations. His mother worked at Boardman Junior High School in Oceanside. Arthur's father Joe (i.e. Robert's paternal grandfather) was cartoonist Jerry Iger's brother.

Iger began his media career in 1972 as the host of "Campus Probe," an Ithaca College television show. He dreamed of becoming a news anchor while he worked as a weatherman in Ithaca for five months, before shifting his career goals. He served as the President of the ABC Television Network Group in New York since 1993. During his years at ABC, he oversaw its broadcast television network and station, cable television, radio and publishing businesses, which includes the market leading brands of ABC, ESPN, Lifetime, A&E and The History Channel.

He served as the Chief Executive Officer of MarketWatch, Inc. since 2006. He was employed at ESPN Holding Company, Inc. He served as the Chairman of the Disney-owned ABC Group since 1996. Mr. Iger has been a Director of The Walt Disney Company since 2000. He has been an Independent Director of Apple Inc. since November 2011. He has been a Board Member of the U.S.-China Business Council since June 2011. He serves as a Director of Hulu Japan LLC. He serves as a Director of National September 11 Memorial & Museum at the World Trade Center Foundation, Inc., Lincoln Center for the Performing Arts, Inc., and New York City Outward Bound. He serves as a Trustee of American Film Institute.

He serves as a Trustee of the Museum of Television and Radio of Ithaca College. He served as a Director of ABC, Inc. since 1994 and Infoseek Corporation since November 1998. Mr. Iger is a Member of the Partnership for a New American Economy, a coalition of mayors and business leaders from across the United States that support comprehensive immigration reform. In June 2010, he was appointed as U.S. President's Export Council, which advises the U.S. president on how to promote U.S. exports, jobs and growth.

In 2012, Mr. Iger became a member of the Academy of Arts & Sciences, one of the nation's most prestigious honorary societies, which recognizes some of the world's most accomplished scholars, scientists, writers, artists and civic, corporate and philanthropic leaders. He serves on the Executive Advisory Board of the Elizabeth Glaser Pediatric AIDS Foundation. He has been named one of Fortune magazine's "25 Most Powerful People in Business" (2006, 2007); one of the "Top Gun CEOs" by Forbes magazine (2009); one of the "Best CEOs" by Institutional Investor magazine (2008, 2009, 2010, 2011); MarketWatch CEO of the Year (2006); and "CEO of the Year" by Chief Executive Magazine (2014). Mr. Iger received a BS in Communications from Ithaca College. As part of his yearly compensation, Iger earned \$44.9 million in 2015.



Viacom and National Amusements- billionaires Sumner Redstone and Shari Redstone

Redstone's father, Michael (Mickey), was a liquor wholesaler, nightclub owner, and drive-in movie operator. As a boy, Redstone studied at the Boston Latin School and went on to attend Harvard College (B.A., 1944) and Harvard Law School (L.L.B., 1947). After practicing law in Washington, D.C., and Boston, Redstone joined his father's company, National Amusements, Inc., in 1954, and in 1967 he became its president and CEO.

Sumner Murray Redstone (born Sumner Murray Rothstein; May 27, 1923) is an American businessman and media magnate. He is the majority owner and chairman of the board of the National Amusements theater chain. Through National Amusements, Redstone and his family are majority owners of CBS Corporation and Viacom (itself the parent company of Viacom Media Networks, BET Networks, and the film studio Paramount Pictures). According to Forbes, as of September 2015, he was worth US \$5 billion. He was ultimately succeeded by Leslie Moonves at CBS and Philippe Dauman at Viacom, where he currently serves as chairman emeritus.
