The Great Jury was accepted and acknowledged by the American National Union of The United States of America in Social Compact in accordance with the Law of Nations and is with jurisdiction and venue within the metes and bounds and seaward boundaries of The United States of America, and

The Great Jury for the American National Union of The United States of America hereby informs the Chief Notary of the War Crimes Tribunal that the Great Jury convened to hear evidence presented by the Claimant, and

It has been determined from the evidence presented within this True Bill of Indictment that there is probable cause to charge the Respondent(s) with:

- ❖ **War Crimes thereby attacking children of their enemy directly under the laws of war**
~ a violation of all Public Laws-101
- ❖ **Terrorism/ Domestic-** a violation of all of Public Laws-101 (**War Crime**)

BRIEF NARRATIVE

The video evidence of a declaration of war on innocent children by the Respondent(s) whom have openly recruited for allies in the Respondent(s) war effort to corrupt and convert the minds of children of mothers and fathers into worshippers of the Satanic worship of the Baal Peor Religion and cannot be tolerated in any nation that is obliged to serve and honor God. Further the Respondent(s) are hereby charged with violating the **1st Law of Noah**- Do not worship idols, evidenced within the symbols displayed of the rainbow-colored war flag (annexed as EXHIBIT A & EXHIBIT B) mocking the Most High's covenant with Noah never to destroy the earth again by flood, and

Wherein it states in [Luke 17:2](#)

The Respondent(s) representing the Baal Peor Religious Community are hereby charged with **Terrorism/Domestic**- a violation of all of Public Laws-101 (**War Crime**) for Respondent(s) war declaration on innocent children starting at the 19 minute and 54 second mark of this International Public Notice; [LINK](#), and

The Respondent(s) are hereby charged with capital crimes against society for *declaring war* on innocent children by confessing to the crimes of subverting the minds of innocent children through a slow process of converting children into the Baal Peor religion of homosexuality in violation of the Public Religion established by and between the people for The United States of America in accordance with the **Law of Nations Chapter 12 §129 and §131**

The authority to establish a public religion is cited herein:

Excerpt from the Law of Nations Book 1 Chapter 12 *Of Piety and Religion §129. Public establishment of religion*

“The establishment of religion by law, and its public exercise, are matters of state, and are necessarily under the jurisdiction of the political authority. If all men are bound to serve God, the entire nation, in her national capacity, is doubtless obliged to serve and honour him (Prelim. §5). And as this important duty is to be discharged by the nation in whatever manner she judges best,—to the nation it belongs to determine what religion she will follow, and what public worship she thinks proper to establish.” [LINK](#)

The authority to protect and support the religion established by the political authority:

Excerpt from the Law of Nations Book 1 Chapter 12 *Of Piety and Religion §131. When there is an established religion.*

“When the choice of a religion is already made, and there is one established by law, the nation ought to protect and support that religion, and preserve it as an establishment of the greatest importance,— without, however, blindly rejecting the changes that may be proposed to render it more pure and useful: for we ought, in all things, to aim at



perfection (§21). But as all innovations, in this case, are full of danger, and can seldom be produced without disturbances, they ought not to be attempted upon slight grounds, without necessity, or very important reasons. It solely belongs to the society, the state, the entire nation, to determine the necessity or propriety of those changes; and no private individual has a right to attempt them by his own authority, nor consequently to preach to the people a new doctrine. Let him offer his sentiments to the conductors of the nation, and submit to the orders he receives from them.”, and

It is the legal obligation of a Nation bound together through social compact to see that justice prevail in the least burdensome and most expedient manner in accordance with Law of Nations Book 1 Chapter 13 Of Justice and Polity §158. *A nation ought to make justice reign; and*

The Great Jury for the American National Union of The United States of America renders this True Bill of Indictment with the authority from and in accordance with Article 15 of the Bi-Lateral Social Compact Agreement by and between the people for The United States of America where in it states:

“**Article 15:** The people agree that in all indictments of agreement, the truth may be given in evidence; and if it shall appear to the Great jury that the evidence is true, and published with good motives and for justifiable ends, the truth shall be a justification; and the Great jury shall be the judges of the law and facts; and”
