The Great Jury was accepted and acknowledged by the **American National Union of The United States of America** in Social Compact in accordance with the Law of Nations and is with jurisdiction and venue within the metes and bounds and seaward boundaries of The United States of America, and

The Great Jury for the American National Union of The United States of America hereby informs the War Crimes Tribunal for The United States of America that the Great Jury convened to hear evidence presented by the Claimant, and

It has been determined from the evidence presented within this True Bill of Indictment that there is probable cause to charge the aforementioned Respondent with:

- ❖ **Violating Article 1 of the Nuremberg Code (War Crime)**
- ❖ **International Terrorism-a violation of all Public Laws-101**
- ❖ **Article 20 (1) of the International Covenant on Civil and Political Rights,**
- ❖ **Violating Article 20 (2) of the International Covenant on Civil and Political Rights**

Respondent Paul Allan Offit, a top advisor to the Food and Drug Administration (hereinafter, "FDA") is hereby charged with **Terrorism- a violation of all Public Laws-101** for publicly inciting vaccinated civilians to discriminate against unvaccinated civilians and children [LINK](#) and depriving the unvaccinated civilians the right to life, liberty and security of persons in violation of **Article 20 (2) of the International Covenant on Civil and Political Rights** [LINK](#)

The Great Jury agrees that the Respondent has **violated Article 1 of the Nuremberg Code** (War Crime) [LINK](#) for publicly promoting experimental vaccination inoculations [LINK](#), by means of the Emergency Use Authorization (hereinafter, "EUA"), and

The Great Jury finds the Respondent to be in violation of **Article 20 (1) of the International Covenant on Civil and Political Rights**, for promoting war propaganda in a contrived war effort against an invisible enemy, nefariously using experimental inoculations under the EUA [LINK](#), thereby warranting the charge of committing an act of **International Terrorism** against the inhabitants as well as the permanent population of The United States of America bound together in Social Compact Agreement, and

The Great Jury for the American National Union of The United States of America renders this True Bill of Indictment with the authority from and in accordance with Article 15 of the Bi Lateral Social Compact Agreement by and between the people for The United States of America wherein it states:

**"Article 15:** The people agree that in all indictments of agreement, the truth may be given in evidence; and if it shall appear to the Great jury that the evidence is true, and published with good motives and for justifiable ends, the truth shall be a justification; and the Great jury shall be the judges of the law and facts; and"
