The Great Jury was accepted and acknowledged by the **American National Union of The United States of America** in Social Compact in accordance with the Law of Nations and is with jurisdiction and venue within the metes and bounds and seaward boundaries of The United States of America, and

The Great Jury for the American National Union of The United States of America hereby informs the War Crimes Tribunal for The United States of America that the Great Jury convened to hear evidence presented by the Claimant, and

It has been determined from the evidence presented within this True Bill of Indictment that there is probable cause to charge the aforementioned Respondent(s) with:

- ❖ Violation of Article 1 of the Nuremberg Code (War Crime)
- ❖ International Terrorism-Violation of all Thirty (30) Articles of Public Laws-101
- ❖ Violation of Article 20 (2) of the International Covenant on Civil and Political Rights
- ❖ Violation of the Law of Nations Book I, Chapter XIII § 158 (Capital Crime)
- ❖ Violation of Article 31 (International Terrorism) & Article 34 of the Bi-Lateral Social Compact Agreement by and between the people for The United States of America (Political Crime of Communism)

The Great Jury agrees that Respondent Edward Miner Lamont Jr. and family are hereby charged with War Crimes in violation of the informed consent principle on medical experimentation codified as International Law within **Article 1 of the Nuremberg Code** for mandating experimental vaccinations [LINK](#) upon civilians [LINK](#), and

The Great Jury agrees that the Respondent is committing acts of **international terrorism** upon the civilian inhabitant populace in **violation of all Thirty (30) Articles of Public Laws-101**, for conspiring with medical personnel, classified as international terrorists [LINK](#) to force mandatory experimental vaccinations [LINK](#) citing [LINK](#) the World Health Organization (WHO), and the Centers for Disease Control and Prevention (CDC), both of which have been declared internationally as satanic organizations by the United States, in Congress assembled, [LINK](#) and whose orders have been outlawed within Article 31 of the written and published social compact agreement of the political authority [LINK](#) within the metes and bounds and seaward boundaries of The United States of America [LINK](#), and

The Great Jury agrees to hereby charge the Respondent with the political crime of Communism, a violation of Article 34 of the afore listed social compact agreement, by claiming medical power of attorney for the civilian inhabitant populace where there is no authority to do so, and wherein no underlying emergency exists, as the SARS CoV-2 has an overall survivability rate of 99.7% globally, [LINK](#) and has a survivability rate comparable with the common flu [LINK](#) , and

The Great Jury agrees that the Respondent has violated Article 20 (2) of the International Covenant on Civil and Political Rights by inciting to discriminate against unvaccinated civilians and children by depriving civilians and children the right to life, liberty and security of persons, and

Further, the Great Jury agrees that Respondent acting as governor for the political subdivision of Connecticut being absent a written and published social compact agreement does not have the Legal obligation to administer justice thereby committing a capital crime in violation the Law of Nations Book I, Chapter XIII § 158, wherein it states:

Excerpt from Law of Nations Book I, Chapter XIII § 158: "Next to the care of religion, one of the principal duties of a nation relates to justice. They ought to employ their utmost attention in causing it to prevail in the state, and to take proper measures for having it dispensed to every one in the most certain, the most speedy, and the least burthensome



manner. This obligation flows from the object proposed by uniting in civil society, and from the social compact itself.”, and

The Great Jury for the American National Union of The United States of America renders this True Bill of Indictment with the authority from and in accordance with Article 15 of the Bi Lateral Social Compact Agreement by and between the people for The United States of America wherein it states:

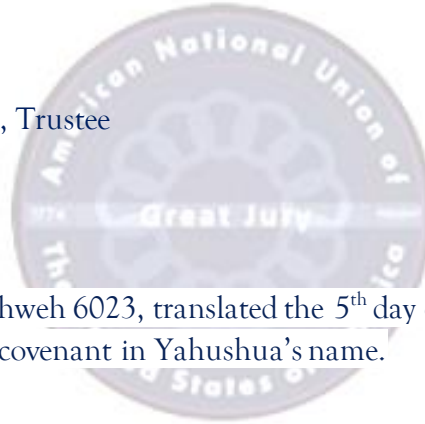
